**JUDGMENT**

**DELIVERED BY HON'BLE MRS., JUSTICE REKHA DIKSHIT, CHAIRPERSON.**

This claim petition has been filed by petitioner under Section-4 of the U.P. Public Services Tribunal, Act 1976 for following relief:

**“(i) The Hon’ble Tribunal may kindly be pleased to issue an order or direction to the opposite parties to make payment of arrears of Dearness Allowances which are due for the year-2009 to 2015, in the interest of justice.**

**(ii) The Hon'ble Tribunal may kindly be pleased to pass any order or direction which it deems just and proper in the circumstances of the matter alongwith the cost of the claim petition in the interest of justice.**

2. Petitioner has given representation dated 23.01.2023 to Opposite Party No. 2 to make payment of arrears of Dearness Allowances which are due for the year-2009 to 2015 . Since matter is engaging attention of Chief Medical Officer, District-Sambhal, opposite Party No. 2. I am not inclined to interfere in the matter at this stage. Consequently, after hearing learned counsel for petitioner and learned P.O. I dispose of this claim petition at admission stage directing Chief Medical Officer, District-Sambhal, opposite Party No. 2 to take a decision on petitioner's representation dated 23.01.2023 by passing speaking and reasoned order within period of three months from the date of receipt of certified copy of this order.

4. It is clarified that I have not made any comment upon the merit of case.
